# "Just a Reminder"

While we may not always appreciate them, we usually need them. These are reminders. Throughout our life we receive them gratefully, or perhaps we are resistant to them. In any event, with the help of hindsight, we come to appreciate them more and more. We know the form some of those reminders take. "Don't forget!" Did you remember!" Make sure you!" Certainly there are more, but the basic idea is the same.

We mainly need reminders in situations when we try to run on "auto-pilot." Unfortunately, those are the times when we tend to forget things. It could be as simple as keys, identification, phones, or something more worrisome, like losing track of your children.

It is interesting, but as time moves on we need more and more reminders. I for one appreciate reminders, especially when my schedule becomes more frantic.

As we approach a new year with a new ministry plan for our congregation, it would be a well-timed reminder to consider our personal stewardship of the gifts God has entrusted to our care. These can be summarized as time, talents, and treasures. And let's be honest, from time to time who doesn't need a reminder, simply because it is so easy to do things the way we have always done them.

Two experiences come to mind. One was from the congregation where I did my vicar year. There was a man who consistently talked about two topics. One was how much money he made working for General Motors for seemingly doing very little. The other was he freely admitted he gave one dollar a week for the work of the church. It wasn't until he received a gentle reminder that he became aware of what

he was doing. The thought never crossed his mind that he was being unfaithful in the use of his God-given gifts.

This is why you and I need a gentle reminder from time to time. We can lose sight of what personal stewardship is. It is much more than giving money to keep the lights on, the building in good repair, or making sure the pastor gets paid. It is all about returning our joyful and grateful thanks to the Lord for the rich way he has blessed us. When we approach the use of our possessions from this perspective, we appreciate the reminder, because it aids us in being more faithful to our Lord and Savior. This is what our stewardship always needs to reflect—growing in the grace of our Lord Jesus Christ.

Now let's recall the basics. The Bible helps us understand what God-pleasing stewardship is. It can be summed up in the words, planned, priority and percentage. Each of these have Scriptural support.

Stewardship is something we plan. We all need to have budgets. Unlike the government we cannot deficit spend, print more money, or raise taxes. We have a finite amount of resources to cover sometimes an infinite amount of needs. This is why a budget, or a plan is imperative.

A plan helps us consider how we will use every gift the Lord has given us. With the guidance of prayer and the Scriptures, we can put into practice what Paul encourages: "Each one should give as he has determined in his heart, not reluctantly or under pressure, for God loves a cheerful giver" (2 Corinthians 9:7).

This is a good reminder, because there

are times when we run on auto-pilot, or we simply forget. That is, until the offering plate comes down the aisle. Then, hastily we either throw something in the plate, or we scribble an amount on a check and stick it into our envelope. A good plan starts with considering what we have received from the Lord. Then, make it your routine to write the very first check each week or month as a thank offering to the Lord. After that decision has been made, work out the rest of your budget. From my experience, most people who plan this way never seem to find themselves with "nothing left for the Lord." The new creation which the Lord has brought about through the working of the water and the Word, delights in serving the Lord with a plan. That plan can include gifts, the use of time, and the use of our abilities.

The second reminder we need is that our stewardship needs to be in proportion to the way the Lord has blessed us. Paul reminded the Corinthians—"On the first day of every week, each of you is to set something aside in keeping with whatever he gains" (I Corinthians 16:2).

Old Testament believers were commanded to use a tithe. However, when one examines what the Lord actually prescribed for his people, the tithe was almost thirty percent. Still, the Lord was not interested in their sheep, sacrifices, or monetary gifts. He wanted their hearts first. This is where proportionate giving actually starts for the New Testament Christian. Once we have our hearts purified through the working of the Gospel and the Holy Spirit, our attitude changes. Instead of assuming the Lord asks too much, we actually believe and put into practice the words of the hymnist:

O Lord of heaven and earth and sea, to you all praise and glory be!

How can we thank you properly who gives us all?

Dear Lord from you we all derive our life, our gifts, our power to give.

Oh may we ever with you live, who gives us all!

A third reminder which is helpful is to make good stewardship our priority. I recall one family I served over 20 years ago. Both the husband and wife had regular income which was more than ample to cover their obligations. Still, they were always looking to the congregation for financial aid to pay their bills. Because this was a regular occurrence, the Church Council asked me to meet with them. I had asked them to list their income and their expenses. Then I asked them to prioritize them. I was amazed at what their priorities were. I was also amazed that a gift to their Lord didn't even make the top ten. When I asked about this omission, they apologized. "Oh, we forgot about that, but the church is right up there."

Our Savior speaks as to how we are to prioritize the use of our God-given gifts. He teaches during the Sermon on the Mount: "Seek first the kingdom of God and his righteousness, and all these things will be given to you as well" (Matthew 6:33). You and I need our Savior's reminder every time we look at our personal budgets. Our stewardship is not an obligation. It is opportunity to put the Lord first in everything we do. This is what he deserves, and what he desires from us as his blood-bought and holy people.

This leads to the final reminder we need. It is a privilege to serve the Lord. Here is where we need to check the thoughts and attitudes of our hearts. There is a broad spectrum of obstacles we have to overcome. All need to be addressed with the words our Lord places before us: "Honor the Lord with your wealth, with the first fruits of all your crops" (Proverbs 3:9).

The best place you and I need to begin is at the cross, and the first thing we need to do is confess:

"Forgive us, Lord, for shallow thankfulness,

for dull content with warmth and sheltered care;

For songs of praise for worldly wealthiness,

while of your richer gifts we're unaware."

# Ministry and Funding Plan

The congregation's approved Ministry and Funding Plan for 2018 is broken out into nine (9) categories as shown below:

For 2018, the total expenses for all categories total \$149,064 which is a 6.8% decrease over the actual 2017 expenses.

The General Fund income for 2018 was calculated by taking the average per month giving for the last 6 months of 2017 and multiplying that by 12. The decrease is primarily due to some active members of the congregation moving out of California, in addition to offerings not meeting our prayerful expectations.

As a result of the projected decrease in offerings, the Council was forced to eliminate the Capital Budget expense (part of the Church Operations category). This expense transferred \$1,250 per month into the Capital Fund to be used for upkeep and long term improvements to the Church buildings (including the Parsonage) and the Church grounds. Instead, for 2018, only income in excess of expenses will be transferred to the Capital Fund. Unless offerings are increased to cover normal consumer price index increases (currently about 2% per year) this could have a long term adverse impact on the care and maintenance of the church's property.

For example, the Capital Fund had over \$23,000 at the end of 2017. The Trustees have been considering potential plans to update the Sanctuary. After 40 years, there is a need new flooring, and the benches either need to be replaced or repaired because they are de-laminating. The Trustees are looking at several alternatives:

1) new pews or refurbishing existing pews,

- 2) replacing pews with chairs,
- 3) combination of pews and chairs.

We are also looking at replacing the carpet with a combination of "hard" flooring and carpet for easier

maintenance and enhanced acoustics. After the first look at the costs for each of these alternatives, it appears that \$23,000 won't be enough to accomplish the project, along with maintaining a reserve for "capital projects"—for example, future roof and parking lot repair More information will be coming out on this in the months ahead and will take into account the state of the Capital Fund under this new budget.

The largest increase was in the Pastoral Support category. This category includes a 2.2% increase in Pastor's salary, a 6% increase in health insurance costs (\$1,344), and an 11% increase in Pastor's Synod pension plan contribution. The health and pension costs are mandated by Synod as part of their Synod-wide insurance coverage plans.

We pray that this 2018 ministry and funding plan will be more than fully funded so that we can continue to fulfill our mission in 2017 which is to grow in the grace and knowledge of our Lord Jesus Christ; to encourage one another in that faith; and to proclaim the gospel of Christ in our community

## "Famine of the Word in America?"

"The days are coming," declares the Sovereign Lord, 
"when I will send a famine through the land—
not a famine of food or a thirst for water,
but a famine of hearing the words of the Lord."

Amos 8:11 NIV

Paul Eichmann (WELS), in the *People's Bible Series* commentary on Amos, notes this prophecy was fulfilled among the Israelites because they followed other Gods. With emphasis on Darwinian evolution and humanism, and little Bible reference in current literature and entertainment, is Amos 8:11 again being fulfilled in the United States? Were there times here when the "words of the Lord" were more available? I think so, and relatively recently.

I was raised to the mid-'60's without religious training, but not without "words of the Lord." Numerous television programs included reference to our Savior! I watched *Hopalong Cassidy, Roy Rogers, The Lone Ranger, Dragnet*, etc. Stories promoting good citizenship, honesty, and Christianity! References not just to "God," but to "the Lord" were common.

An example is the 2<sup>nd</sup> episode of *The Rifleman* with a fine summary (see page 7) of the *Book of Job*! How well do you think a three-minute Bible monologue would fare in today's television market? Such a script likely would not get past the recycle bin.

Watching programs like *The Rifleman*, an irreligious boy (me) could not avoid hearing "words of the Lord" sixty years ago, even with no church attendance or mention at home. Today, my grandson Jameson likely is not hearing many "words of the Lord" except in church, Sunday School, and at home. With the relative lack of the Word of the Lord, even in many mainstream churches, a "famine" exists now that I don't think was nearly as severe a half-century ago.

Amos' prophecy from the Lord: "I will send a famine throughout the land...a famine of hearing the words of the Lord." This seems like something Satan would do, but he didn't remove "the words of the Lord" from Israel! No, the Lord removed his words! Reverend Eichmann notes "people who refuse to hear the Word of the Lord finally *cannot* hear it, because God takes his Word away."

Of Paul's admonition "Now is the time of God's favor, now is the day of salvation" (2 Corinthians 6:2), Luther noted "the preaching of the gospel is not an eternal, lasting, continual teaching, but it is like a passing shower which travels on. Some ground is watered and another place stays dry. It does not return and also does not stand still. Then the hot sun comes and licks up the moisture that remains."

I fear the "words of the Lord" may disappear as they did from the Israelites. Have the people of the United States strayed from the Lord since the '50's? Is there a possible famine of the word on the horizon? It could happen. Nonetheless we have every reason to redouble our Christ-centered efforts to reach the lost! We need to go and tell!

# **The Book of Job** in The Rifleman

In the 2nd, 1958, Rifleman episode, a neighboring rancher's hired-hands burned down Lucas McCain's house to force him off the land. Stunned, his son Mark cries out "Pa! Looks to me like the Lord's dead-set against us!"

Lucas responds: "Help me saddle up, boy, I want to tell you a story. A long time ago in a country so far west it's almost due east of here lived a great stock-man with a beard so long it reached his belly-button. His name was Job. Job had seven sons, seven daughters and seven-thousand head of fine cattle and sheep. Not to mention a considerable amount of camel stock.



Job was top dog with the Lord because he was so hard-workin' and righteous. The Lord never lost a chance to brag on him! He made a point of tellin' the Devil about the old man. How he hated evil, avoided temptation, and most important: How he never lost his faith in God!

Well, the Devil switched his tail and laughed. He allowed that Job was such a good man because everythin' was goin' his way. Just give him some trouble and he'd switch sides in a hurry! Well, the Lord thought this over and then he said he'd give the Devil a Hog's dollar against a Penny's worth of brimstone that Job would keep faith with his maker no matter what trials he put on him.

Well, the Devil sent some rustlers on the old man's stock, and then he called up a big wind that knocked down his house and killed all his children. The old man's beard turned white with grief. But he held steadfast. So the Devil reared back and saddled him all over with festerin' boils. Mark, Job was as miserable as a man can be. He got himself a piece of broken jug, sat out in the corral doctorin' his boils and shakin' ashes over his head bewailin' his fate: Wonderin' why the Lord had forsaken him until finally three of his 'friends' came up. They told Job that wailin' about the situation only made it worse and it looked to them like he'd sinned somewhere along the line and 'Why didn't he repent?'

Job jumped right back at them! He said he'd repent when he had somethin' to repent about! He knew he'd been good and righteous and while he might complain about his lot, he'd not lost faith in the Lord: 'Oh, that my words were now written and printed in a book riven with chisel on granite rock forever, for I know that my Redeemer liveth, and that he shall stand beside me later on.' That's how the old man put it.

Well, Mark: The Devil was plumb wore out, so he just tossed in his chips and quit the game. The Lord was so proud of Job that he restored all the old man's children and his house, his camels and sheep, and gave him over twice as many cattle as he had before! Job lived a hundred an' forty years happy as a bird-dog, and finally died bein' old and full of days."

Mark thought a moment, then said: "Makes our troubles look kinda piddlin', don't it?"

At the cross, our thoughts and our actions are purified by the shed blood of our Savior. Yes, Jesus died not only to take away the obvious sins which plague our life, he also died to take away those seemingly insignificant ones which over time can drive the same wedge between us and God. These are the sins against the First Commandment where we do not "fear, love and trust in God above all things." We also need to pray that God would strengthen the new creation through the working of the Holy Spirit: "Create in me a pure heart, O God. Renew an unwavering spirit within me. Do not cast me away from your presence. Do not take your Holy Spirit from me. Restore to the joy of your salvation. Sustain me with a willing spirit. (Psalm 51:10-12).



# **Never Alone with Jesus**

"Suddenly, when they looked around, they no longer saw anyone with them except Jesus."

Mark 9:8

The disciples must have been disappointed. One moment they saw a glimpse of heaven. Jesus allowed his glory as God to be seen. Moses and Elijah miraculously appeared. God the Father's praise majestically echoed from the cloud. The next moment everything was gone. All that remained was the familiar form of Jesus.
